2023 VIP PASS

Attendance at the event is subject to these terms and conditions.

1. This ticket admits 1 person and 1 guest to attend Melbourne Design Fair 2023.
2. The right of admission is reserved by the Organiser. Children aged 15 and under must be accompanied by an adult at all times.
3. This ticket cannot be transferred to another individual or exchanged for cash.
4. Advertised programs or tours may be varied without notice. Exhibitors may be added, withdrawn or substituted and the right to vary audience capacity is reserved.
5. Entry is subject to venue capacity.
6. Ticket holders enter the venue at their own risk.
7. All bags may be subject to a visual inspection.
8. This ticket may not be resold for commercial packages or at a premium, nor may it be packaged or used for advertising, promotional or other commercial purposes. If a ticket is sold in breach of this condition, the bearer of the ticket may be refused admission.

2. The organisers reserve the right to search all ticket holders and their belongings at the point of entry and exit.
3. Refusal to allow a search at the point of entry will result in the ticket holder being refused entry.
4. All bags larger than a laptop size bag must be checked into the cloakroom at the point of entry and can be retrieved when leaving. Refusal to check a bag when asked to do so will result in the ticket holder being refused entry.
5. Entry with items that in the opinion of the organisers may constitute a threat to safety and security is prohibited.
6. No unauthorised work may be brought into the fair.
7. No photography of works is permitted without the permission of the exhibitor. No use of tripods without permission. Selfie sticks are not permitted in the Fair.
8. No unauthorised distribution of flyers or other marketing materials is permitted in the fair.
9. All children under 15 must be accompanied by an adult. Please keep your children close to you at all times.
10. No animals with the exception of assistance dogs are allowed into the fair.
11. Smoking and vaping are not permitted.
12. This event may be photographed and filmed for news, webcasts, promotional purposes, telecast, and advertising including online. By entering you consent to being photographed or filmed and waive all rights to royalties or payment.
